Graduate Student Petition for In-State Tuition Classification

The State of Colorado partially subsidizes the cost of tuition for all students whose domicile, or permanent legal residence, is in Colorado. Tuition classification determines if students should have in-state or out-of-state tuition.

The tuition classification law ("tuition law") sets forth conditions for a student being considered as "in-state" for purposes of tuition classification. The tuition law is contained in sections 23-7-101 to 104, and 23-7-105 of the Colorado Revised Statutes.

In-state tuition classification status for graduate students requires *domicile* (legal, primary residence) of the student in Colorado for the year immediately preceding the first day of class. During the one-year domicile period, students should have taken all actions that would be expected of any permanent resident of Colorado.
